On December 9, 2014, UNS Energy Corporation (“UNS Energy”), Tucson Electric Power Company (“TEP”), UNS Electric, Inc. (“UNSE”) and UNS Gas, Inc. (“UNSG”) (collectively, “Companies”), filed a request to extend the December 10, 2014 compliance date for filing their list of “all waivers of Commission Rules that remain in effect as well as any conditions imposed on the utilities as a result of other prior Commission Orders.” On January 16, 2015, the Utilities Division (“Staff”) issued its Staff Report recommending an extension be granted until January 31, 2015. In the Staff Report, Staff indicated that the Companies filed their request on December 12, 2014, which was after the December 10, 2014 compliance date.

The Companies filed their request on December 9, 2014 – prior to the December 10, 2014 compliance date -- but did not include the entire service on the filing. On or about December 11, 2014, Staff contacted counsel for the Companies and requested that they refile to include the full service list. On December 12, 2014, the Companies refiled their extension request with the entire service list.

The Companies believe that they filed their request in a timely manner.
