## **INTERIM EMERGENCY SURCHARGE**

### **MONTEZUMA RIMROCK WATER COMPANY, LLC**

Effective March 19, 2014

Decision No. 74382

The Arizona Corporation Commission approved an interim emergency surcharge in Decision No. 74382 dated March 19, 2014, to be used by the Company toward payment of its arsenic treatment facility and associated building leases.

The interim surcharge of \$10.00 per customer per month will be effective on March 19, 2014. This interim surcharge will terminate upon the effective date that rates approved in Montezuma Rimrock Water Company's pending rate case become effective. The funds collected pursuant to the interim emergency surcharge can be used only toward payment of Montezuma Rimrock's arsenic treatment facility and associated building leases. **The interim surcharge will be in addition to existing approved tariffs.**
