**BY THE COMMISSION:**

On August 21, 2014, Tonto Basin Water Company, Inc. ("Tonto Basin" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase based on a test year ended June 30, 2014.

On January 30, 2015, a Procedural Order was issued in this matter granting intervention to Brooke Utilities, Inc., effective upon the filing of a notice of appearance by counsel or the filing of evidence of a board resolution authorizing a specifically named officer of the corporation to represent it, which demonstrates compliance with the requirements of Arizona Supreme Court Rule 31(d)(11).

The January 30, 2015 Procedural Order incorrectly cited the Arizona Supreme Court rule that applies to lay representation before the Commission. This Procedural Order is issued to correct that citation error.

IT IS THEREFORE ORDERED that Brooke Utilities, Inc. is hereby granted intervention, effective upon the filing of a notice of appearance by counsel or the filing of evidence of a board resolution authorizing a specifically named officer of the corporation to represent it, which demonstrates compliance with the requirements of Arizona Supreme Court Rule 31(d)(28).
