
**REQUEST FOR EXTENSION TO FILE SURREBUTTAL TESTIMONY**

15 The Residential Utility Consumer Office ("RUCO") hereby requests an extension of three  
16 days to file its surrebuttal testimony, in the above-referenced matter. Robert Mease and  
17 Jeffrey Michlik have been involved in three days and possibly four days of hearing in the Utility  
18 Source matter which has made it difficult for them to complete their surrebuttal testimony by  
19 February 23, 2015. In addition, RUCO is still waiting for responses from the Company to some  
20 of its data requests.

22 Therefore, RUCO requests an extension from February 23, 2015, to February 26, 2015,  
23 to file its surrebuttal testimony. Staff and Company have been contacted. EPCOR's position is  
24 to support a two-day extension for intervenors, with a similar two-day extension for Company

1 rejoinder. Staff supports RUCO's motion. This extension would apply similarly to the other  
2 intervenors and the Company rejoinder.
