COMMENT SESSION**


Pursuant to the Procedural Order issued by Administrative Law Judge Kinsey on December 10, 2014 and as amended on January 13, 2015, Circle City Water Company LLC (Circle City”) does hereby file this request to amend the previously issued Procedural Order in order to reschedule the public comment session originally scheduled for March 2, 2015.

Unintentionally, the offices of Circle City, after receipt of the modified Procedural Order of January 13, 2015 where most of the previous Procedural Order was vacated, mistakenly did not properly notice that language at page 2, lines 19 and 20, providing for a hearing on March 2, 2015 for the purpose of taking public comments. This hearing was to include a properly noticed Public Notice as prescribed on page 3 and 4 of the December 10, 2014 Procedural Order. Publication of the Public Notice and mailing of the required Public Notice has not yet occurred and additional time is required

1 in order to facilitate this requirement. Circle City sincerely apologizes to the
2 Administrative Law Judge, the Hearing Division and the Commission for this
3 unintentional oversight and respectfully requests that a hearing for the purpose of taking
4 public comments be rescheduled so that proper notice can be accomplished as provided
5 in the Procedural Order. Circle City appreciates any consideration given for this purpose.


