5 Having considered the entire record herein and being fully advised in the premises, the
6 Commission finds, concludes, and orders that:

7 **FINDINGS OF FACT**

8 1. On May 30, 2014, the Arizona Corporation Commission (“Commission”) issued
9 Decision No. 74504 in this consolidated matter, in which the Commission established rates and
10 charges for Montezuma Rimrock Water Company, LLC (“Montezuma”), resolved several financing
11 applications filed by Montezuma, and adjudicated a Formal Complaint filed against Montezuma by
12 John E. Dougherty. In the Decision, *inter alia*, the Commission ordered the following:

13 IT IS FURTHER ORDERED that to ensure the Commission is
14 apprised of Montezuma Rimrock Water Company, LLC’s performance
and conduct, the Commission’s Utilities Division shall monitor
15 Montezuma Rimrock Water Company, LLC’s compliance with this
Decision for the next 24 months. Every six months from the effective date
16 of this Order and for a period of 24 months, the Company shall file a
compliance report regarding its adherence to the requirements of this
17 Decision and Commission rules, regulations, and statutes. Within 2
months after each of the Company’s filings, Staff shall file a Compliance
18 Report detailing the status of Montezuma Rimrock Water Company,
LLC’s compliance with this Decision and with all applicable Commission
19 statutes, rules, Decisions, and Orders during the period in question and
making a recommendation concerning the Company’s compliance or lack
20 thereof, and whether a Show Cause proceeding should be initiated and
other adverse action taken.¹

21 2. On November 5, 2014, Montezuma filed a Notice of Filing Montezuma Rimrock
22 Water Co. LLC Compliance Report.

23 3. The language quoted above from Decision No. 74504 created a filing deadline of
24 January 5, 2014, for the Commission’s Utilities Division (“Staff”) to file its Compliance Report
25 regarding Montezuma.


