**PUBLIC NOTICE OF THE HEARING ON THE APPLICATION OF THE CITY OF  
GLOBE FOR APPROVAL TO AMEND DECISION NO.33424 PURSUANT TO A.R.S. §  
40-252 (DOCKET NO. W-01445A-14-0305)**

On August 18, 2014, the City of Globe ("Globe") filed with the Arizona Corporation Commission ("Commission") an application requesting approval to amend Decision # 33424. Globe's application requests that the Commission amend or correct its Decision filed September 20, 1961 concerning the boundaries of a Certificate of Convenience and Necessity ("CC&N") granted to Arizona Water Company ("AWC"). AWC has denied the allegations in the application and asked that it be dismissed. The Commission is not bound by the assertions of Globe or AWC. The Commission will issue a Decision regarding Globe's application following consideration of the parties' positions, and any testimony and evidence to be presented at an evidentiary hearing. A copy of the application is available at Globe City Hall, 150 N. Pine St. Globe, Arizona 85501 and at the Commission's office at 1200 W. Washington Street, Phoenix, Arizona for public inspection during regular business hours, and on the internet via the Commission website ([www.azcc.gov](http://www.azcc.gov)) using the edocket function.

The Commission will hold a hearing on Globe's application on \_\_\_\_ 2015 at \_\_\_\_ a.m. at the Commission's office, 1200 W. Washington, Hearing Room No. \_\_, Phoenix Arizona 85007. Public comment will be taken on the first day of the hearing. Written public comments may be submitted via the Commission's website at [www.azcc.gov](http://www.azcc.gov) by clicking on the "Submit a Public Comment" button or by mailing a letter referencing Docket No. W-01445A-14-0305 to: Arizona Corporation Commission, Consumer Services Section, 1200 W. Washington St., Phoenix, Arizona 85007. If you require assistance, you may contact Consumer services Section at 1-800-222-7000 or 602-542-4251.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Any person or entity entitled by law to intervene and having a direct and substantial interest in the matter will be permitted to intervene. If you wish to intervene, you must file an original and 13 copies of a written motion to intervene with the Commission no later than \_\_\_\_, 2015, and send a copy of the motion to all parties of record. Your motion to intervene must contain the following:

1. Your name, address, and telephone number and the name address and telephone number of any person upon whom service of documents is to be made, if not yourself;
2. A short statement of your interest in the proceeding (e.g. a customer of Globe, etc.);
3. A statement certifying that you have mailed a copy of the motion to intervene to Globe or its counsel and to all parties of record in the case; and

4. If you are not represented by an attorney who is an active member of the Arizona State Bar, and are not representing yourself as an individual, information and any appropriate documentation demonstrating compliance with Arizona Supreme Court Rules 31, 38 and 42, as applicable.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before 2015. If representation by counsel is required by Arizona Supreme Court rule 31, intervention will be conditioned upon the intervenors obtaining counsel to represent the intervenor. For information about requesting intervention, visit the Commission's website at <http://www.azcc.gov/divisions/utilities/forms/interven.pdf>. The granting of intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at the hearing and providing public comment on the application or from filing written comments in the record of the case.

The Commission does not discriminate on the basis of disability in admission of its public meetings.
