EARNINGS REPORT

Johnson Utilities, L.L.C., ("Johnson Utilities" or the "Company") hereby requests an extension of the date for filing the 2014 earnings report that is currently due on February 27, 2015, pursuant to Decision 74695. Completion of the earnings report is dependent upon the completion of substantial accounting work for the 2014 calendar year. Johnson Utilities is awaiting accounting reports from its outside accountant, and the Company has additional internal accounting work to complete before it is in a position to prepare the 2014 earnings report. Public utilities are required to file annual reports for the prior year by April 15 of the current year. This filing date acknowledges that there is substantial work that goes into the preparation of such reports after year-end. Johnson Utilities requests that the Commission extend the date for filing the 2014 earnings report until April 30, 2015. Approval of the requested extension will not prejudice any party in this docket.


