REGARDING
PROCEDURAL ORDER

Trico Electric Cooperative, Inc., an Arizona nonprofit corporation, ("Trico" or "Company"), through undersigned counsel, responds to Staff's Response to Trico's Request for Procedural Order, filed March 19, 2015.

First, Trico will proceed with the application in this docket and will not withdraw any part of the application.

Second, Trico does not oppose a hearing in this docket. However, it does not believe that the hearing on its application should be conducted in conjunction with hearings on any other similar applications.


Third, the procedural schedule proposed by Staff is acceptable to Trico. However, Trico requests that a procedural order be issued promptly setting forth the public notice requirements for the application, the intervention deadline and the hearing date. With respect to the actual hearing date, key witnesses for Trico, Trico's counsel or both are unavailable during the period June 17, 2015 through July 13, 2015.

Finally, should the Staff's proposed schedule require modification, Trico requests a procedural conference to discuss the procedural schedule.
