Dear Mr. Olea:

Arizona Commission Decision 72015 approved the transfer of control of Talk America, Inc. ("Talk America") to PAETEC Holding Corp. The final ordering paragraph of Decision 72015 directed PAETEC Holding Corp. and Talk America to:

[P]rovide commission Staff with a copy of the post-merger customer notice/packages use to inform customers of the proposed transaction. The copy should be provided within 30 days of the issuance of such notice/package to all customers.

Enclosed is the post-merger notice sent out to all Talk America Arizona customers dated December 6, 2010. The notice letter informed customers that Talk America's parent company, Cavalier Telephone, had merged with PAETC. At the time, Talk America customer bills included Cavalier Telephone brand information, making customers aware that Cavalier was Talk America's parent company. As Decision No. 72015 explains, no Talk America customers were transferred as a result of the transaction. See Decision 72015 page 2, para. 8.

This merger was one merger, in a continuum of mergers, that began with the Paetec-McLeodUSA merger (2008), followed by this merger Paetec-Talk America (2010), and

culminating in Windstream's acquisition of McLeodUSA d/b/a Paetec (2012). *See* Decision Nos. 70126, 72015, 72670. As the carriers' regulatory compliance offices coalesced and employees changed, it appears this notice was not submitted within 30 days of issuance of the notice. Paetec apologizes for this omission. Importantly, the notice letter was sent to Arizona customers.
