Dear Sir or Madam:

Blue Jay Wireless, LLC (Blue Jay or the Company) has been designated by the Arizona Corporation Commission (Commission) as an Eligible Telecommunications Carrier for the provision of wireless Lifeline services.¹ In its application, Blue Jay stated that it would provide, among others, the following tribal Lifeline offerings in Arizona:

- 1000 anytime voice minutes/texts without rollover and with text messaging assessed at a rate of 1 minute per text message for sending and one minute per text message for receiving text messages, at a charge of \$1.00 per month; and
- Unlimited voice minutes (no texts) at a charge of \$5.00 per month.

Due to market considerations, Blue Jay has decided to improve its Lifeline offering with respect to the tribal plans so that eligible tribal subscribers will receive their choice of:

- Unlimited voice and text at no charge;
- Unlimited voice and text plus 500 MB of data for a charge of \$5.75 per month; or
- Unlimited voice and text plus 5 GB of data for a charge of \$14.75 per month.

Further, Blue Jay is offering additional "top-up" plans as follows:

- Lifeline Unlimited Voice and Text for a charge of \$26/month
- Lifeline Unlimited Voice and Text with 500 MB of data for a charge of \$30.75/month
- Lifeline Unlimited Voice and Text with 5 GB of data for a charge of \$40/month

Revised tariff pages reflecting these changes and discontinuing certain other top-up offerings are enclosed with this notice.

Blue Jay's marketing of the modified plan will be implemented consistent with any necessary state notices and regulatory approvals. In accordance with the Order granting Blue Jay's ETC application, it is the Company's understanding that no further notice or approval is required from the Commission in connection with this modification.

Tribal Service Plans:

- **Tribal Resident Lifeline Unlimited Voice and Text Plan.** Each month the subscriber will receive unlimited anytime voice minutes and text messages for free. There are no rollover minutes with this plan as minutes and texts are unlimited. This plan will only be available to eligible residents of tribal lands. (C), (D)
- **Tribal Unlimited Voice and Text with 500 MB Data.** Each month the subscriber will receive unlimited anytime voice minutes and text messages by paying \$5.75 per month plus applicable fees and taxes. Additionally, each subscriber will receive a maximum of 500 MB of data. There are no rollover minutes with this plan as minutes and texts are unlimited and there is also no rollover data. This plan will only be available to eligible residents of tribal lands. (N), (D)
- **Tribal Unlimited Voice and Text with 5 GB Data.** Each month the subscriber will receive unlimited anytime voice minutes and text messages by paying \$14.75 per month plus applicable fees and taxes. Additionally, each subscriber will receive a maximum of 5 GB of data. There are no rollover minutes with this plan as minutes and texts are unlimited and there is also no rollover data. This plan will only be available to eligible residents of tribal lands. (N)

Additional Minutes Plans (“Top-Ups”)

- Lifeline Subscribers may purchase additional minutes plans on a non-recurring basis. Unused minutes and messages expire at the end of Lifeline Subscribers’ monthly period and may not be used in subsequent months. If Lifeline Subscribers use all of their monthly voice minutes and messages before a new monthly cycle starts and they add an Additional Minutes Plan to their account, they will be charged based on the Additional Minutes Plan they choose for voice calls and messages. Even following purchase of an additional minutes plan, if Lifeline Subscriber uses all of the minutes included in the plan, Lifeline Subscriber will not have the ability to make calls or send receive messages, except to place 911 calls, until another additional minutes plan is purchased or a new monthly cycle starts. Additional Minutes Plans ("Top-Ups") (cont.)

Additional minutes plans can be purchased at all Company payment locations as well as additional retail locations which are only authorized to sell Company top-ups. Company top-ups are available in increments of \$5.00, \$10.00, and \$20.00. Purchased additional minutes plans cannot be transferred or applied to any other wireless service or account.

Lifeline customers also may purchase Additional Minute Plans in the following increments:

- Lifeline Unlimited Voice and Text for \$26.00
- Lifeline Unlimited Voice and Text with 500 MB Data for \$30.75
- Lifeline Unlimited Voice and Text with 5 GB Data for \$40.00
