14 **BY THE COMMISSION:**

15 Having considered the entire record herein and being fully advised in the premises, the  
16 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

17 **FINDINGS OF FACT**

18 1. On June 27, 2013, the Commission issued Decision No. 73932 authorizing an  
19 emergency rate increase for Tacna Water Management Company ("Tacna" or "Company").

20 2. The Decision stated that if Tacna failed to file a permanent rate application by  
21 September 30, 2014, the emergency rates would terminate on October 1, 2014. The Decision also  
22 held open this docket until the Commission approved permanent rates.

23 3. On April 28, 2015, the Company filed a request to extend the rate application filing  
24 deadline to July 1, 2015.

25 4. On June 12, 2015, the Commission's Utility Division ("Staff") filed a Memorandum  
26 recommending approval of the request and that the deadline be extended to July 15, 2015.

27 5. In the Memorandum, Staff noted that it had been working with the Company on the  
28 rate application and believed Tacna could complete the application by July 15, 2015.

IT IS THEREFORE ORDERED that the filing deadline for Tacna Water Management Company to submit its permanent rate application is extended to July 15, 2015.

IT IS FURTHER ORDERED that if Tacna Water Management Company fails to docket its permanent rate application by July 15, 2015, all interim rates and charges authorized by the Commission in Decision No. 73932 shall expire on August 3, 2015.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
