**REQUEST FOR EXTENSION OF TIME
FOR FILING TESTIMONY**

Due to ongoing settlement negotiations between the City of Globe and Arizona Water Company (collectively the "Parties"), the Parties would request that the due dates for all testimony in the above captioned docket be moved back two weeks so that the City of Globe's testimony would be due on July 10 and subsequent dates for all other testimony adjusted accordingly. The Parties have spoken with the Arizona Corporation Commission Staff about this issue and Staff did not have concerns. The procedural schedule was initially set up with significant time between the date the last round of testimony was due and the hearing would commence. These extended dates will not affect the prehearing conference or hearing dates as previously established. The Parties would respectfully request a Procedural Order that adjusts the due dates for testimony in the new procedural schedule.


