ORDER AMENDING DECISION NO. 74695

BY THE COMMISSION:

The Commission entered Decision No. 74695 on August 12, 2014. Decision No. 74695 required in relevant part that Johnson Utilities, LLC., dba Johnson Utilities Company ("Company") file its next rate case by June 30, 2016, using a 2015 test year. On May 22, 2015, the Company filed a request to amend Decision No. 74695 to either remove the rate case filing requirement, or in the alternative, to extend the deadline for filing its next rate case to June 30, 2017, using a 2016 test year.

After considering the filings in this matter as well as parties' comments at the Open Meeting, the Commission finds that the public interest is served by granting the requested time extension for the filing of the Company's next rate case.

Pursuant to A.R.S. Section 40-252, with notice and opportunity to be heard, the Commission hereby amends Decision No. 74695 to extend the time for the Company's filing of its next rate case to June 30, 2017, using a 2016 test year.

The Commission has jurisdiction over this subject matter and the Company's request to amend Decision No. 74695.

ORDER

THEREFORE, IT IS ORDERED that Decision No. 74695 is amended to extend the date by which Johnson Utilities, LLC., dba Johnson Utilities Company is required to file its next rate case from June 30, 2016, using a 2015 test year to June 30, 2017, using a 2016 test year.


IT IS FURTHER ORDERED that the provisions of Decision No. 74695 not specially amended herein continue to remain in effect.
