On June 17, 2015, Arizona Department of Transportation ("ADOT") filed an application with the Arizona Corporation Commission ("Commission") to grant BNSF Railroad Company ("Railroad") authority to modify the railroad-highway crossing located at the intersection of Grand Avenue and Thunderbird Road. Commission Railroad Safety Section Staff ("Staff") has examined the application and has concerns regarding the content of the application and whether the matter is sufficiently developed that it would be appropriate to process and grant such authority to the Railroad. Staff has been in communication with representatives of ADOT and the Railroad regarding Staff's concerns but has not received information that would dispel Staff's concerns. Consequently, Staff requests the scheduling of a procedural conference in this matter so that Staff may address its concerns to the Administrative Law Judge.
