In compliance with Decision No. 72665 in the above-referenced docket, Cricket Communications, Inc. ("Cricket") hereby files its Quarterly Report regarding Lifeline Subscribers for the quarter ending June 30, 2015.

1. As of June 30, 2015, Cricket had 2,877 Lifeline subscribers in Arizona. Please note that this is an estimate because it is reported prior to a final reconciliation that is completed after 60 days from the end of the calendar month.
2. Cricket does not remove customers from its customer base due to 60-days inactivity.
3. Cricket did not perform its annual verification/recertification of Lifeline subscribers during the second quarter of 2015 and, as a result, did not remove any Lifeline subscribers from its customer base due to recertification failure.
4. With respect to voluntary relinquishment of service, no customers were disconnected due to non-payment of the monthly service charge for the quarter ending June 30, 2015.
