12 **BY THE COMMISSION:**

13 On June 17, 2015, the Arizona Department of Transportation ("ADOT") filed with the  
14 Arizona Corporation Commission ("Commission") a request for approval for ADOT to construct a  
15 new grade separated crossing and for the BNSF Railway ("Railway") to remove an existing at-grade  
16 crossing at US 60 and Bell Road in the City of Surprise ("City"), Maricopa County, Arizona at  
17 USDOT No. 025392A ("Application").

18 On July 9, 2015, the Commission's Railroad Safety Section of the Safety Division ("Staff")  
19 filed a request for a procedural conference to address certain concerns of Staff prior to a hearing  
20 being scheduled.

21 Accordingly, a procedural conference should be scheduled.

22 IT IS THEREFORE ORDERED that a procedural conference shall be held on **August 11,**
