PROCEDURAL ORDER
(Schedules Procedural Conference)

BY THE COMMISSION:

On June 17, 2015, the Arizona Department of Transportation ("ADOT") filed with the Arizona Corporation Commission ("Commission") a request for approval for ADOT to install a new grade separated crossing and for the Union Pacific Railroad Company ("Railroad") to remove an existing at-grade crossing at Interstate 10 ("I-10") and INA Road in the City of Tucson ("City"), Pima County, Arizona at USDOT No. 741 101G ("Application").

On July 10, 2015, the Commission's Railroad Safety Section of the Safety Division ("Staff") filed a request for a procedural conference to address certain concerns of Staff prior to a hearing being scheduled.

Accordingly, a procedural conference should be scheduled.

IT IS THEREFORE ORDERED that a procedural conference shall be held on **August 13, 2015, at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, 2nd Floor Conference Room, Phoenix, Arizona.


