Pursuant to Rule 14-3-105 of the Rules of Practice and Procedure before the Corporation Commission, CP Boulders, LLC, doing business as the Boulders Resort (hereinafter the "Boulders"), respectfully moves to intervene in the above-captioned consolidated matters, Docket Nos. SW-02361A-15-0206 and SW-02361A-15-0207.

1 The Boulders is a commercial customer of sewer collection and treatment services
2 provided by Liberty Utilities (Black Mountain Sewer) Corp. ("Black Mountain") and purchases
3 effluent from Black Mountain that the Boulders uses to water its golf course landscaping. The
4 Boulders will be directly and substantially affected by the proposed rate increase and other
5 proposals in the Applications in these matters.

6 The Boulders' participation in this matter will not unduly broaden the issues nor unduly
7 delay this proceeding, which has just started. The Boulders anticipates addressing through
8 testimony or other evidence and briefing the issues raised in Black Mountain's rate application
9 and supporting schedules and data, direct testimony, and any other issues raised by the parties
10 during the course of these proceedings.
