INTERVENTION

BY THE COMMISSION:

On February 26, 2015, Trico Electric Cooperative, Inc. ("Trico" or "Company") filed an Application For Approval Of Net Metering Tariffs And Partial Waiver Of The Net Metering Rules.

On March 3, 2015, Trico filed a Notice of Waiver of any 30-day "time clock" that would apply to the Application.

On March 9, 2015, Mohave Electric Cooperative, Inc. ("MEC") filed a Request for Intervention. MEC is a member-owned electric distribution cooperative, and states that the issues of this docket are of interest to MEC and its members.

On March 13, 2015 The Alliance For Solar Choice ("TASC") filed an Application for Leave to Intervene. TASC is a solar energy advocacy association whose membership represents the majority of the nation's rooftop solar market. TASC asserts that a decision in this proceeding will directly affect its members.


No party opposed MEC's or TASC's request.


