On May 22, 2002 APS Energy Services Company, Inc. ("APSES") filed a complaint against Tucson Electric Power Company ("TEP") alleging that TEP had refused to provide service under certain of its Qualifying Facilities tariffs to the City of Tucson for a cogeneration facility that the City had contracted with a subsidiary of APSES.


In a Procedural Conference held on June 19, 2002 counsel for both parties indicated that they had reached, or were close to reaching, an agreement in principle that would resolve the issues raised in this complaint. It was determined to keep the docket open pending a future filing from the parties which would indicate whether the matter should be dismissed or set for hearing.

Per the Procedural Order issued on March 20, 2015 by Jane L. Rodda, Administrative Law Judge, given the length of time that has passed since this complaint was filed, it appears that there is no longer a need to keep this docket open. It was ordered that unless any party files a request for Procedural Conference by March 31, 2015 this docket will be administratively closed. No subsequent filings have been made in the above docket. Therefore, this docket is administratively closed.

An Administrative Closure Number has been assigned to this matter which officially closes the docket. **This is not a signed order of the Commission and is for record keeping purposes only.**
