**JOINT REQUEST FOR EXTENSION
OF TIME**

Desert Gas, LP ("DG") and Arizona Corporation Commission – Pipeline Safety Section Staff ("Staff") (collectively the "Parties") jointly request an additional 60-day extension of time before an answer is due to the amended complaint dated February 12, 2015 – or from May 4, 2015 to July 3, 2015. The Parties have made considerable progress toward reaching a settlement agreement in this case regarding the allegations involving the natural gas compressor station in Ehrenberg, Arizona. On March 18, 2015, Desert Gas provided a term sheet to Staff outlining the major settlement terms it proposed. Staff responded on April 7, 2015. DG revised further its proposal and sent it to Staff on April 10, 2015.

The Parties believe that settlement can and will be reached in this case, but are still negotiating certain terms and conditions. The Parties believe additional time is appropriate and that the request is made for good cause. The request is not made for the purposes of delay, and the Parties believe administrative efficiency warrants the further extension.




