(Grants Intervention)

BY THE COMMISSION:

On July 1, 2015, Arizona Public Service Company ("APS") filed with the Commission in this docket a request for approval of its 2016 Renewable Energy Standard ("RES") Implementation Plan.

On August 27, 2015, APS filed a Notice of Withdrawal of Request for Revisions to Rate Rider Schedule LFCR-DG.


On September 11, 2015, the Arizona Solar Deployment Alliance ("ASDA") filed an Application for Leave to Intervene.
