On March 25, 2015 UNS Electric, Inc. ("Company") filed an application with the Arizona Corporation Commission ("Commission") for: (1) approval of a new net-metering tariff for future net metered customers and (2) approval for a partial waiver of the Commission's Net Metering Rules ("A.A.C. R14-2-2301 et seq.).

On April 21, 2015 the Company filed a Motion to Withdraw Application. At the April 27, 2015 Procedural Conference, the Company reiterated its request to withdraw the Application and have the matter considered as part of its rate case expected to be filed in a few weeks. No party objected.

Per the procedural order issued on April 28, 2015 by Jane L. Rodda, Administrative Law Judge, the application is dismissed without prejudice and the docket should be administratively closed.

An Administrative Closure Number has been assigned to this matter which officially closes the docket. This is not a signed order of the Commission and is for record keeping purposes only.
