

On April 1, 2014, UNS Electric, Inc. ("UNS Electric"), in compliance with Decision No. 74235 (December 31, 2013), filed with the Arizona Corporation Commission ("Commission") an application for approval of Partial Requirements Service Tariffs for Residential, Small General Service, Large General Service, and Large Power Service ("PRS Tariffs"). Such PRS Tariffs remain pending. On May 5, 2015, UNS Electric filed a rate case in Docket E-04204A-15-0142. The rate case contains updated proposed tariffs (QF-A, QF-B and QF-C) that are intended to supplant the PRS Tariffs that are currently pending. The proposed tariffs will be considered by the Commission in conjunction with the rate case. Accordingly, UNS Electric hereby requests to withdraw its April 1, 2014 application for PRS Tariffs.
