On October 25, 2013 the Arizona Corporation Commission (“Commission”) issued Decision No. 74155 which approved an application by Cordes Lake Water Company (“Applicant” or “Company”) for an increase in its rates and charges in Docket No. W-02060A-12-0356.

On November 13, 2014 the Company filed the above-captioned application for financing approval in Docket No. W-02060A-14-0387.

On April 17, 2015 the Company filed a Motion to Withdraw Financing Application (“Motion”).

On April 28, 2015 the Commission’s Utilities Division Staff filed its response that it has no objections to the Company’s Motion.

Per the Procedural Order issued on May 13, 2015 by Marc E. Stern, Administrative Law Judge, the Motion to Withdraw Financing Application of Cordes Lakes Water Company was granted. Therefore, these dockets are administratively closed.
