BY THE COMMISSION:


On April 6, 2015, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for Financing Order. TEP seeks to: (1) extend most of the Company's existing financing authority granted in Decision No. 73658 (February 6, 2013) by four years to December 31, 20120; (2) increase the cap on its long-term indebtedness from \$1.7 billion to \$2.2 billion; and (3) increase the cap on its variable-rate long-term indebtedness from \$350 million to \$450 million.

On May 27, 2015, Local Union 1116, International Brotherhood of Electrical Workers, AFL-CIO ("IBEW Local 1116") filed an Application for Leave to Intervene. IBEW Local 1116 is the exclusive bargaining representative of approximately 700 non-managerial TEP employees.

No party objected to IBEW Local 1116's application.

IT IS THEREFORE ORDERED that IBEW Local 1116's intervention is granted.
