

The granting of motions to intervene shall be governed by A.R.C. 114-110, except that the person requesting intervention must file an original and 13 copies of a written motion to intervene with the Commission's Docket Control Center on or before the 15th day after this notice and must serve a copy of the motion to Securus Technologies, Inc. or its counsel.
