Subject: Email from Public for Utilities Division regarding Tucson Electric Power Company Rate Increase

Gentlemen:

We received a notice from Tucson Electric Power Company that the company is requesting review and approval of their 2016 Energy Efficiency Implementation Plan. We have noted that the plan requests your approval to change the Demand Side Management Surcharge from \$.002311 to \$.00295 for residential customers. Reference Docket No E-01933A-15-0178 filed on June 1, 2015.

Please DO NOT approve the increase request for the Demand Side Management Surcharge. For the people on a fixed income, we can barely pay our electric bills today. An increase in charges to electric service takes food out of our mouths and money away from medical care. In 2012 Tucson Electric Power Company removed a rate credit from our bills; in 2013 Tucson Electric Power Company had a 5% increase in residential rates. And again they are requesting a rate increase.

Incomes for retired citizens are not increasing, but our electric bills continue to increase in Tucson.

Please do not approve the Demand Side Management Surcharge rate increase.
