Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On June 13, 2008, the Commission issued Decision No. 70385, granting Tower Cloud, Inc. ("TCI") a Certificate of Convenience and Necessity ("CC&N") to provide competitive special access telecommunications services within the State of Arizona.
2. On April 14, 2015, TCI filed a request to cancel its CC&N, stating TCI has not conducted business or had a presence in Arizona since 2009. TCI's application states it has no intention of pursuing business in Arizona in the future.
3. On July 22, 2015, the Commission's Utilities Division ("Staff") filed a Staff Report in this matter recommending approval of TCI's application to cancel its CC&N.
4. According to the Commission's Consumer Services Section, zero complaints or opinions were filed against TCI for the time period of January 1, 2012 through April 21, 2015.
5. According to the Staff Report, the Corporations Division revoked TCI's registration to conduct business on June 8, 2011, for failure to file its Annual Report.
