 16 ("Tribe"), hereby applies to the Arizona Corporation Commission (the "Commission") for an
 17 order granting the Tribe leave to intervene in the above-captioned docket.

19 The Tribe is a customer of Trico within the Trico service area and is also presently seeking
 20 bids from solar providers for a commercial-scale PV system on the Pascua Yaqui Reservation
 21 located near Tucson, Arizona. The Tribe will be directly and substantially affected by the
 22 decision of the Commission in this matter. The Tribe's participation in this matter will not
 23 broaden the issues nor unduly delay the proceeding.


24 For the reasons outlined above, the Tribe respectfully requests the Commission grant this
