NOTIFICATION OF INTERVENTION

**BY THE COMMISSION:**

On February 26, 2015, Trico Electric Cooperative, Inc. ("Trico" or "Company") filed an Application For Approval Of Net Metering Tariffs And Partial Waiver Of The Net Metering Rules.

On March 3, 2015, Trico filed a Notice of Waiver of any 30-day "time clock" that would apply to the Application.

On March 4, 2015, the Arizona Solar Deployment Alliance ("ASDA"), an Arizona non-profit corporation, filed an Application for Leave to Intervene in this docket. ASDA is comprised of solar companies that install solar arrays in the Trico service area, and asserts that it will be directly and substantially affected by a Commission decision in this matter.

No party opposed ASDA's request.

IT IS THEREFORE ORDERED that ASDA's request to intervene is granted.
