STATUS UPDATE

At the public comment session held on March 2, 2015, Lake Pleasant 5000, L.L.C. ("LP5K") and Maughan Revocable Trust of 2007 and Rex G. Maughan and Ruth G. Maughan ("Maughan") agreed to submit an update on settlement negotiations in the above captioned proceeding and their dealings with Circle City Water Company ("CCWC").

As described in the Status update filed by LP5K and Maughan on February 17, 2015, a settlement offer was made to CCWC. At the time of the March 2 public comment session, CCWC had not responded.

On March 24, 2015, the parties participated in a teleconference call to discuss the above mentioned settlement offer. The parties agreed to speak again next week and to submit another status update to the Commission on April 6, 2015.


