NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On February 26, 2015, Trico Electric Cooperative, Inc. ("Trico" or "Company") filed an Application For Approval Of Net Metering Tariffs And Partial Waiver Of The Net Metering Rules.

On March 3, 2015, Trico filed a Notice of Waiver of any 30-day "time clock" that would apply to the Application.

On March 17, 2015, Navopache Electric Cooperative, Inc. ("NEC") filed a Request for Intervention. NEC is a member-owned electric distribution cooperative, and states that the issues of this docket are of interest to NEC and its members.

On March 18, 2015, Robert B. Hall, Ph.D. ("Hall") filed an Application to Intervene. Hall is an individual who installed a solar array on his residence in Trico's service area and has been in the field of Photovoltaics for years.

No party opposed NEC's or Hall's request.


