**MOTION FOR EXTENSION OF
TIME TO FILE POST-HEARING

22 Utility Source, L.L.C. ("Company" or "Utility Source"), hereby files a motion for
23 an extension of time to file its post-hearing reply brief. The Company requests that the
24 court allow the parties to file reply briefs on or before April 17, 2015.

26 Reply briefs are due on April 14, 2015 currently. The Arizona Corporation
27 Commission has scheduled an Open Meeting on this date as well. Utility Sources'
28 counsel represents clients involved in three matters that have been set on the regular

1 agenda for this Open Meeting (Dragoon Water Company, Inc.; Park Water Company,
2 Inc.; and DII-Emerald Springs, LLC). Collectively, these three matters will take
3 substantial preparation time. The Company's counsel had no prior knowledge that this
4 conflict would arise. The Company believes that moving the due date for the parties'
5 reply briefs back three days to April 17, 2015 will provide the Company enough time to
6 respond appropriately.

9 The Company's counsel has contacted by telephone Staff and RUCO and both
10 agreed to the extension. The Company has also sent intervenors Fallon and Nielsen
11 notice of the proposed extension by email. Nielsen has responded that he has no
12 objection to this motion and Fallon has already filed his response. Accordingly, no party
13 will be prejudiced by this extension. Therefore, the Company moves for an expedited
14 order extending the reply brief deadline from April 14, 2015, to **April 17, 2015** for all
15 parties.


