On February 27, 2015, Johnson Utilities, L.L.C., (“Johnson Utilities” or the “Company”) filed a request (“Request”) for an extension of the date for filing the 2014 earnings report that is required pursuant to Decision 74695. In its Request, Johnson Utilities noted that completion of the earnings report is dependent upon the completion of substantial accounting work for the 2014 calendar year. The Company further noted that public utilities are required to file an Annual Report for the prior year by April 15 of the current year, and that the April filing date acknowledges that there is substantial work that goes into the preparation of such reports after year-end. In its Request, Johnson Utilities requested that the Arizona Corporation Commission (“Commission”) extend the date for filing the 2014 earnings report until April 30, 2015, so that the Company could complete the 2014 Annual Report that is due April 15, 2015. No party objected to the Request.

Johnson Utilities is still completing its 2014 Annual Report. It is the Commission’s policy to allow a one-time 30-day extension of the April 15 filing date upon request by a utility. Johnson Utilities requested a 30-day extension and will file its 2014 Annual Report on May 15, 2015. In order to allow sufficient time to complete the earnings report, The Company hereby requests an extension of the date for filing its earnings report through and including May 29, 2015. Approval of the requested extension will not prejudice any party to this docket.


