11 **BY THE COMMISSION:**

12 Having considered the entire record herein and being fully advised in the premises, the
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. On December 18, 1997, in Decision No. 60530, the Commission granted RRV
16 Enterprises, Inc. ("RRV" or "Company") a Certificate of Convenience and Necessity ("CC&N") to
17 provide competitive resold long distance telecommunications services within the State of Arizona.
18 The Decision also prohibited RRV from collecting advances, deposits, and/or prepayments from
19 Arizona customers without further review of the Company's financial viability by Staff.

20 2. On February 10, 2015, RRV filed a request to cancel its CC&N, stating that RRV was
21 no longer providing telecommunication services in Arizona and had ceased doing business in Arizona
22 no later than December 31, 2013.

23 3. On February 17, 2015, the Company filed a request for a waiver of the notice
24 requirements in Arizona Administrative Code ("A.A.C.") R14-2-1107, asserting RRV had stopped
25 doing business in Arizona by 2012 and that the Company was no longer registered with the
26 Corporations Division.

27 4. On April 14, 2015, the Commission's Utilities Division ("Staff") filed a Staff Report
28 in this matter recommending approval of RRV's application to cancel its CC&N.

ORDER

IT IS THEREFORE ORDERED that the application of RRV Enterprises, Inc. for the cancellation of its Certificate of Convenience and Necessity, granted in Commission Decision No. 60530 (December 18, 1997), to provide competitive resold long distance telecommunications in Arizona is hereby approved and the Certificate of Convenience and Necessity is canceled.

IT IS FURTHER ORDERED that RRV Enterprises, Inc.'s telecommunication services tariff on file with the Commission is hereby canceled.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
