I have a question with regard to how I should provide feedback to the Arizona Corporation Commission regarding Docket # L-00000B-15-0059-00170 for what I believe to be a gray area.

When I visit this site (<u>http://eservice.azcc.gov/Utilities/PublicComment/</u>), I see three choices for providing "Your Position on the Docket". The choices are: "For", "Against", or "Neutral".

From what I have read and researched, I am "For" the route approved by the Line Siting Committee. I believe is is the right place for these power lines to go. However, I do know that for the proposed route that there are a few miles in which the lines would run through residential areas along the railroad tracks and if it were possible to bury the power lines for those few miles, I would prefer that modification. Based on this information, I am not quite sure which radio button to select: For, Against, or Neutral. I am afraid to say I am "Against" the route because I believe this is the right location for the power lines and I think it would be a disaster if these power lines were moved to another more populated neighborhood road, but I am confused if I can be "For" the route but still want the tracks buried for some of the route.

I have seen some e-petitions saying "Ask the ACC to REJECT the route and to bury the lines" and other comments that say "Ask the ACC to ACCEPT the route but suggest they bury the lines". There is a lot of public confusion over "For" vs. "Against" and/or. "Accept" vs. "Accept with Modifications" vs "Reject" so thank you for any help you can provide in clearing up this confusion.

Dear Commissioners,

We are writing to you today in regard to the 230kV line extension proposal recently approved by the ACC's Transmission Line Siting Committee. It calls for overhead 230kV power lines connecting the Schrader Substation near Ocotillo Road and Arizona Ave in Chandler to a new RS-28 Substation north of the Sun Lakes communities. The proposed route connecting these two substations is south along the Union Pacific Railroad tracks, crossing Hunt Hwy onto the Gila River Indian Community (GRIC), going west on the Community lands, and then north along the west side of Sun Lakes to RS-28, to be located north of the Sun Lakes communities.

We are not opposed to the project, the route, nor the stated purpose. It makes sense to provide the power to where it is currently needed, and to where it will be needed, on the Price Road corridor. It makes sense to partner with GRIC to help them accomplish some of their stated objectives and to support a new solar farm on their lands. It does <u>not</u> make sense, however, to permanently impact the aesthetics, the safety, and the property values of homeowners along the route's path who will see absolutely no direct value out of this project. It does <u>not</u> make sense to run overhead 230kV transmission lines adjacent to/through established residential neighborhoods along the railroad tracks from the Schrader Substation to the Hunt Hwy, and also west of the Sun Lakes communities, in order to accomplish stated objectives elsewhere.

If these overhead line sections are actually constructed as proposed, our views of the mountains, sunrises, and sunsets will be <u>irreparably harmed forever</u>. Our home values will most assuredly go down. Personal safety concerns will certainly arise from those living near the overhead lines, and potential aircraft mishaps will always be a concern from flights in and out of the expanding Gila River Memorial Airport to the west and the Chandler Municipal Airport to the east. Why allow all of this to happen? It cannot be reversed once approved and built.

We ask that you please vote to modify the submitted proposal by burying the lines along the Union Pacific Railroad tracks from the Schrader Substation to the Hunt Hwy, and also west of the Sun Lakes communities. Thank you in advance for your positive consideration of this request.

I agree that an independent estimate of the cost of underground power lines should be obtained. My guess is that SRP ginned up a figure to suit their purposes and are now citing the cost to justify their dismissiveness of even seriously considering going underground.

I also expect that what they claim to be negotiations with Gila River Reservation people are not proceeding with any haste or honest attempts at accomplishing anything. This is route is as legitimate as any proposed and deserves to be explored in good faith. The other proposals can be put on hold until we have an answer on the reservation citing.

As an aside, I believe the Gila River folks should hold out for underground lines, too.
