**NOTICE OF
NON-CONSUMMATION**

On May 2, 2014, Time Warner Cable Information Services (Arizona), LLC, d/b/a Time Warner Cable ("TWCIS"), Time Warner Cable Business LLC, d/b/a Time Warner Cable ("TWCB"), and Comcast Phone of Arizona, LLC, d/b/a Comcast Digital Phone ("Comcast Phone") (collectively, the "Applicants"), filed an application (the "Application") requesting a limited waiver of the affiliated interest rules or, alternatively, expedited approval, on behalf of their parent corporations, Time Warner Cable Inc. ("Time Warner Cable") and Comcast Corporation ("Comcast"), of Comcast's proposed indirect acquisition of TWCIS and TWCB as a result of a proposed merger with Time Warner Cable (the "Transaction").

On June 30, 2014, the Arizona Corporation Commission's Utilities Division filed a Memorandum recommending that the Dockets be administratively closed because the Applicants' waiver had become effective pursuant to Arizona Administrative Code R14-2-806(C) on June 2, 2014, the 31st day following the filing of the Application. Pursuant to a Procedural Order issued by Administrative Law Judge Sasha Paternoster on July 3, 2014, the Dockets were administratively closed.

The Applicants hereby provide notice to the Arizona Corporation Commission that the Transaction described in the Application has been terminated and will not be consummated.¹ The Applicants have provided, and will continue to provide, services pursuant to their respective certifications and tariffs effective in Arizona prior to the Application.


