14 Having considered the entire record herein and being fully advised in the premises, the
15 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

16 **FINDINGS OF FACT**

17 1. In Commission Decision No. 60836 (April 30, 1998), the Commission granted Metro
18 Vending of Arizona, Co. ("MVOA" or "Applicant") a Certificate of Convenience and Necessity
19 ("CC&N") to provide customer owned pay telephone ("COPT") services in Arizona.

20 2. On February 24, 2015, MVOA filed an application with the Commission requesting
21 approval to cancel its CC&N to provide COPT services in Arizona. In the application, MVOA
22 waived its right to notice and a hearing to cancel its CC&N. The application further notes that
23 MVOA no longer provides COPT services in the state of Arizona and that Mr. Mark Bons is
24 authorized to file the application on behalf of the Applicant.

25 3. On April 21, 2015, the Commission's Utilities Division ("Staff") filed a Memorandum
26 in response to MVOA's application to cancel its CC&N.
