Re: *Docket No. E-01345A-11-0224; Joint Motion to Extend Arizona Public Service Company's Experimental Rate Rider Schedule AG-1*

Dear Sir or Madam:

On November 20, 2014, several Arizona Public Service Company ("APS" or "Company") customers served under Experimental Rate Rider Schedule AG-1 ("AG-1") and a group of providers of that service (collectively referred to herein as the "Joint Movants") filed a Joint Motion to Extend AG-1 under its present terms until the conclusion of APS's next general rate case. APS filed an opposition to the Joint Motion on December 1, 2014.

On March 10, 2015, Commissioner Little filed a letter in this Docket requesting that the Company meet and confer with the Joint Movants to determine if there could be some agreement allowing continuation of AG-1 after July 1, 2016. Subsequent to Commissioner Little's letter, APS has met on several occasions with the Joint Movants and now believes the parties have come to an agreement in principle on this matter. As soon as this agreement has been committed to writing and executed on behalf of the Company and the Joint Movants, APS and the Joint Movants will make a formal filing with the Commission which, if granted by the Commission, will allow for continuation of AG-1 after July 1, 2016. APS expects such a filing will be finalized and submitted to the Commission by mid-June, more than a year prior to the otherwise-expected end of the AG-1 program.
