ORDER

BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. In Commission Decision No. 67168 (August 10, 2004), the Commission granted Synergy Telecom Service Co., Inc. ("Synergy" or the "Company") a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") telecommunication services in Arizona.
2. On March 11, 2015, Synergy filed an application with the Commission requesting approval to cancel its CC&N to provide COPT services in Arizona. Synergy's application stated that the Company no longer or never did provide COPT service in Arizona; that the Company waives its right to notice and a hearing; and that Mr. John H. Crawford was authorized by the Company to file the application.
3. On May 21, 2015, the Commission's Utilities Division ("Staff") filed a Memorandum in response to Synergy's application to cancel its CC&N. Staff states that the Commission's

1 Consumer Services Section reports that no complaints have been filed against Synergy from January
2 1, 2012 through March 13, 2015; that Synergy's status as an Arizona Corporation was revoked on
3 August 24, 2012, for failure to file an Annual Report for the years 2012, 2013, and 2014; and that the
4 Company's last Utilities Annual Report was filed in 2008, but that the Commission's Compliance
5 Section reported that the Company is otherwise in compliance. Staff recommends approval of the
6 Company's application to cancel its CC&N and that upon cancellation of Synergy's CC&N, the
7 Company will no longer be authorized to provide COPT telecommunication services in Arizona, or
8 be subject to the requirements set forth in Decision No. 67168.

9 4. Staff's recommendations are reasonable and should be adopted.

10 **CONCLUSIONS OF LAW**

11 1. Synergy Telecom Service Co., Inc. is a public service corporation within the meaning
12 of Article XV of the Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

13 2. The Commission has jurisdiction over Synergy Telecom Service Co., Inc. and the
14 subject matter of the application.

15 3. The cancellation of Synergy Telecom Service Co., Inc.'s CC&N to provide customer
16 owned pay telephone telecommunication services in Arizona is in the public interest.

17 4. Staff's recommendations are reasonable and should be adopted.

18 **ORDER**

19 IT IS THEREFORE ORDERED that Synergy Telecom Service Co., Inc.'s application for
20 approval to cancel its Certificate of Convenience and Necessity to provide customer owned pay
21 telephone telecommunication services in Arizona, is hereby approved.
