STAFF'S REQUEST TO RESCHEDULE  
PROCEDURAL CONFERENCE

On June 4, 2015, the Hearing Division issued a Procedural Order (Reschedules Procedural Conference) ("Procedural Order") which granted Intervenor Lake Pleasant 5000, L.L.C.'s ("LP5") May 27, 2015, Request to Reschedule Procedural Conference Date ("Request"). The Procedural Order reset the procedural conference previously scheduled for June 8, 2015, to August 11, 2015, at 10:00 a.m.

Though the Arizona Corporation Commission Utilities Division ("Staff") would prefer not to do so, it must request to reschedule the August 11, 2015, procedural conference. Undersigned counsel was previously assigned to the Quail Creek Water Company, Inc. ("Quail Creek") rate case (Docket No. W-02514A-14-0343) the hearing for which commences August 11, 2015, at 10:00 a.m. and is set for two days. As a result, the undersigned is unable to appear at the currently scheduled procedural conference.

For the benefit of the Hearing Division, Staff counsel contacted the parties to this matter to advise of this conflict and request their respective known unavailable dates in anticipation of the Administrative Law Judge's need to know of potential future scheduling conflicts. The parties are unavailable on the following dates: Circle City Water Company, Inc. ("Circle City"): August 12, 17-21 and 27 and September 3, 4, 10 and 22; Maughan Revocable Trust ("MRT"): June 15-19; and, Staff: August 20, 21 and 28 and September 4. Counsel for LP5 advised that his calendar is clear in August and September.

1 Based on the foregoing, Staff respectfully requests that the August 11, 2015, Procedural  
2 Conference be rescheduled to another date mutually convenient to all parties and this tribunal.
