Attached, please find a compliance filing regarding water loss as required in the afore-referenced decision. This attached water loss report summarizes water production and water consumption from June of 2014 through May 2015.


Please note some improvements from our last report regarding TCS (Gisela):

- A major leak was found in the back of the property and has been repaired. May has the least water lost in a long time, however, more can be done.
- As stated previously, a source of the problem could be a series of old water lines which served areas destroyed by flooding about a decade ago. It is possible that one or more of these lines was not properly capped, or has subsequently split/ broken and may be leaking without any customers or Company staff noticing (since much of this area is no longer served by roads, and is overgrown.
- Stolen water: It is likely that unknown or illegal connections have been made recently to the water system. Locations of recent property construction, excavations and trenching in the Company's ROW will be explored to determine if water is being used at unauthorized locations.

Also, please note that the water loss percentage calculations for MDC (Mesa Del Caballo) had a faulty calculation. The entire report has now been fixed, and as you can see, MDC is one of the least water lost in the Company.
