**PROCEDURAL ORDER GRANTING

**BY THE COMMISSION:**

On May 5, 2015, UNS Electric, Inc. ("UNS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application to determine the fair value of the utility property of the Company for ratemaking purposes, to fix a just and reasonable rate of return thereon, and to approve rate schedules designed to develop such return.

On July 15, 2015, pursuant to Arizona Supreme Court Rule 38(a), Timothy M. Hogan, an attorney for Vote Solar, filed with the Commission a Motion to Associate Counsel *Pro Hac Vice* for Michael Alan Hiatt in the above-captioned matter ("Motion"). The Motion lists Mr. Hogan as the designated member of the Arizona State Bar with whom communications may be made and upon whom papers should be served. 
