**UNOPPOSED MOTION FOR
LEAVE TO PRESENT
TELEPHONIC TESTIMONY**

The August 6, 2015 procedural order in this case directs Midvale Telephone Company ("Midvale") to provide a witness for the August 26, 2015 hearing. Midvale's witness will be Dennis Farrington, Chief Operating Officer of Midvale. If not permitted to testify by phone, Mr. Farrington will have to travel from Prescott to Phoenix, a two hour trip each way. Midvale's other potential witnesses are located in its main office in Midvale, Idaho. Mr. Farrington's testimony is expected to be very brief, simply stating that Midvale does not object to the transfer of parcel 300-45-003A to Table Top Telephone Company, Inc. Telephonic testimony is often permitted by the Commission, especially in uncontested telecommunication matters such as this case. In this case, the nature of Mr. Farrington's testimony and the necessary travel time support allowing telephonic testimony.
