STAFF'S REQUEST FOR  
CLARIFICATION

Staff of the Arizona Corporation Commission ("Staff") supports the Recommended Opinion and Order ("ROO") issued on August 3, 2015. Staff believes the ROO is well-reasoned and strikes the appropriate balance with respect to the issues raised in this proceeding.

Staff requests that the ALJ make the following two minor clarifications to the discussion on page 31 of the ROO.

- 1) At line 14, strike "\$5 per month on DG customers" and insert the following in its place: "\$.70 per kW of DG system size, resulting in approximately \$5 per month (based on average system size) on new DG customers."
- 2) At line 25, strike the words "cost shift" and in its place insert "lost fixed cost".
