NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On May 5, 2015, UNS Electric, Inc. ("UNSE" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase. By Procedural Order dated June 22, 2015, the matter was set for hearing to commence on March 1, 2016, and other procedural guidelines were established.

On July 24, 2015, The Arizona Community Action Association ("ACAA") and Cynthia Zwick filed a Motion to Intervene in the above-captioned docket.

ACAA is a non-profit organization that provides services to low-income Arizonans to ensure energy affordability. Ms. Zwick is the executive director of AECC. The Motion indicates that ACAA has authorized Ms. Zwick to represent it in this matter.

There were no objections filed to the intervention request.


