STAFF MOTION TO CONSOLIDATE

On September 24, 2015, Arizona Department of Transportation ("ADOT") filed four applications with the Arizona Corporation Commission ("Commission") to grant authority for Union Pacific Railroad ("Railroad") to upgrade one crossing per application in or around the City of Nogales. All of the crossings have previously been included on the Commission approved railroad crossing array pursuant to Decision No. 73610 (December 12, 2012).

Due to the common factual circumstances surrounding each of the crossings and the close geographical proximity of the crossings, Commission Railroad Safety Section Staff ("Staff") believes that consolidation of the four applications would be appropriate and permit a more efficient processing of these four applications.

For all these reasons, Staff moves to consolidate Docket Nos. RR-03639A-15-0331, RR-03639A-15-0332, RR-03639A-15-0333, and RR-03639A-15-0334.
