Dear Docket Control,

On October 2, 2015, Cricket received a Notice of Future Compliance regarding a compliance filing ordered in Decision No. 72665 in the above-referenced docket.

However, pursuant to Decision No. 75096 in Docket No. T-20721A-15-0038, Cricket relinquished its ETC designation in Arizona on July 31, 2015. In response to an inquiry by Cricket regarding the need to file an October 15 quarterly compliance report, Brian Bozzo sent an email to Janice Ono and me confirming that the October 15 quarterly compliance reports (for the time period ending September 2015) as well as future quarterly reports would not be necessary. Attached is a copy of that email.

Ms. Ono-

I have had a chance to review some of the documents filed relating to the ETC relinquishment and have additionally discussed some of the compliance items with Lori Morrison. I agree with Ms. Morrison about the quarterly reports on the Lifeline Subscribers and the Lifeline Complaints regarding the filings being current and also with her position that the ETC relinquishment renders the ongoing provision of those reports as unnecessary. I believe a September report is no longer required for those items.

I also reviewed other items for Cricket from Decision No. 75096 and 72665. Several were for notice issues which have now been addressed in the compliance database. They are considered met due to previous filing(s) and the discussions with Ms. Morrison about the relinquishment of the ETC designation. Of course, the Company can still have compliance items. We currently have a pending compliance item on the shutdown of the legacy CDMA network which Ms. Morrison says could be done relatively soon.

I hope this information helps and thank you for your inquiry. It is an opportunity for us to clean up compliance matters prior to any formal meetings or hearings.

Hi Brian and Lori,

I have a compliance question for you.

Recently Cricket received approval from the ACC to relinquish its Lifeline-only ETC designation effective July 31, 2015 (see Decision 75096 attached, dated 5/19/2015).

Pursuant to the original Cricket ETC order's (D. 72665) compliance items, Cricket has been filing quarterly reports regarding the number of Lifeline complaints and Lifeline subscribers. The next quarterly report will be due on October 15, 2015. Since the relinquishment will be effective July 31, 2015, Cricket would only be reporting for the time period July 1-30, 2015.

Given that this last quarter would only be for final 30 days, will the ACC require Cricket to submit a report on October 15? Many states have not required Cricket to continue with reports once their ETC relinquishment application was granted.
